

E-Visa applicable for specific Nationals to enter and leave the specific District and Oblast in The Russian Federation.

An E-Visa to enter the **Far Eastern Federal District (FE)**, **Kaliningrad Oblast (KGD)** and **St. Petersburg & Leningrad Oblast (LED)** can only be obtained by nationals of the following states, listed by the Government of the Russian Federation.

1. An **e-visa is free of charge**. Not required any Invitations, visa support for application.
2. **Issuance is no longer than 4 calendar days** from the date of submission of the complete application.
3. **E-visa is a single-entry visa** and issued for 30 calendar days from the date of its issuance.
4. **Permitted stay** in the Russian Federation is up to **8 days starting from the date of entry**, within its validity period. E-visa validity and/or the permitted stay under it cannot be extended.
5. E-visas can be of the following categories only: **purpose of journey is business, tourism**, and purposes are **sports, cultural, scientific and technological ties**.
6. E-visa can be used for entering and leaving the Russian Federation at the following checkpoints at the national border in the Far Eastern Federal District, Kaliningrad Oblast, Saint-Petersburg and Leningrad Oblast.
7. An e-visa for the selected entity of the Russian Federation is only valid for entering and leaving the Russian Federation at the mentioned national border checkpoints.
8. Foreign citizens who have arrived to the Russian Federation with e-visas have the right to freedom of movement within the territory of the constituent entity of the Russian Federation which they entered, with the exception of territories, organizations and facilities, to enter which a special permission is required in accordance with federal laws of the Russian Federation.
9. Foreign citizens should leave the territory of the Russian Federation only through checkpoints of the constituent entity of the Russian Federation which they entered.
10. Entry and exit on an **e-visa by means of rail transport is currently unavailable**.

11. **Application for an e-visa on website not earlier than 20 days and no later than 4 days** before the intended date of entry into the Russian Federation.
12. Applicant passport must be valid for **at least 6 months from the date applied** and the passport must have **free space** for border crossing stamps.
13. Foreign citizens who have arrived to the Russian Federation with e-visas are required to have a **medical insurance valid in the Russian Federation's territory for the entire period of stay**.

E-visa application procedure

1. To start a new application, click the "[Proceed to Fill in the Application](https://evisa.kdmid.ru)" button on the <https://evisa.kdmid.ru>
2. To continue filling in, edit, review or print the completed application choose the "Retrieve application" menu item.
3. Enter Applicant personal e-mail address and confirm it, then enter password for this site and confirm it.
4. Write down or print the Application ID displayed in the top right corner of the page. It will be required to continue the application if the session has been disconnected. To save the draft application, click the "Save the Draft" button. The e-visa application form will be available within 30 days since its last save.
5. Proceed to fill in the fields of the application. Follow the tips on each page of the application. Fields marked with an asterisk (*) are required. If any errors while filling in the form or have not filled in the required fields, they will be highlighted and a message will appear under them indicating the error need to fix.
6. Upload the Applicant's digital color photo in the JPEG format. The photo must meet the requirements.
7. Click the button sending the application and wait for the confirmation of its acceptance for processing.

After sending application:

Applicant can use the site to follow up on the status of application. Once a relevant decision is taken, the status of the application will be changed to "Visa issued" or "Visa denied". Applicant will be able to download a PDF file with the information concerning the decision on the application thereafter. Automatic messages concerning the status of your application and the decision thereon as well as detailed instructions for further steps will be sent to your personal e-mail.

Download and print the notification with your e-visa. Otherwise, save the information set out in the notification, so that applicant could visually present it to representatives of a transport company when getting on a vehicle and passport control officers at a national border checkpoint when entering the Russian Federation.

IMPORTANT NOTE: Do not save the PDF file with the result of application examination on the computer that can be accessed by those who have no permission to view or record the applicant personal data. If applicant save the file to the hard drive of a public computer, for instance, in an Internet café or a library, other users may find and open it.

If applicant have not received a notification of e-visa grant or e-visa refusal within four days, applicant can apply for a visa as per standard procedure at a diplomatic mission or consular office of the Russian Federation.

ATTENTION! Notification of e-visa grant does not guarantee entry into the Russian Federation. Applicant can be denied entry at a border crossing point should the circumstances referred to in Federal Law No. 114 FZ "On the Procedure of Exit from the Russian Federation and Entry into the Russian Federation" of August 15, 1996 arise.
